SECTION 17 FROM EXHIBITOR TERMS AND CONDITIONS:

17. INSURANCE

- Exhibitor shall, at its sole cost, obtain and continue in force the following insurance protection in connection with the exhibit:
- A. Public liability and property damage insurance, including general liability, products liability, personal injury, contractual liability and automobile liability coverages, in the amounts set forth in this paragraph, as will protect Licensor and Exhibitor from claims, demands and liabilities for injuries to or death of persons, and for injury to or loss of property, arising directly or indirectly from Exhibitor's setup, or dismantling, or Exhibitor's display properties, or from the use of any portion of the Los Angeles Convention Center by or on behalf of the Exhibitor, or its principals, constituents, suppliers, subcontractors, manufacturers or employees, or its patrons or invitees. Public liability and property damage insurance under this paragraph shall provide coverage on a per occurrence basis and shall have policy limits of not less than One Million Dollars (\$1,000,000.00) per occurrence of bodily injury or death and property damage. Each insurance policy shall be issued by an insurance carrier rated "B+" or higher by A.M. Best Co. Each policy shall also conform to the following requirements:
- Ansa Productions, Inc., DBA Los Angeles Auto Show and Greater Los Angeles New Car Dealers Association shall be named as Additional Insureds under each such policy with respect to all liability coverages.
 - All liability coverages under each such policy shall be primary as to Exhibitor and as to the Additional Insureds.
 - Each such insurer shall issue an endorsement adding the Additional Insureds with respect to all coverages, with 30 days notice of cancellation to be given by the insurer to each Additional Insured.
- B. All-risk property insurance with waiver of subrogation shall be obtained by Exhibitor covering the full value of all personal and business property in the custody of Exhibitor and its agents, including full replacement value, business interruption, and the loss-of-use coverages. All claims are hereby waived as to Licensor, as to the Greater Los Angeles New Car Dealers Association, as to the Indemnities referred to in paragraph 16 hereof, and as to the City of Los Angeles, for property damage, business interruption, loss of use of property, and all other similar losses, for which all-risk property insurance is required to be obtained by Exhibitor under this Exhibitor License Agreement.
